Admission conditions and procedure

Admission is open to

- anyone who can prove that they have completed a degree in fine arts at a German art academy or a comparable foreign institution;
- who can provide evidence of professional exhibition and publication activities or a qualified artistic practice;
- who has been accepted by a BBK committee responsible for admission according to the criteria described above.

Applications should preferably be submitted digitally. In addition to the application for admission, please submit a portfolio. This should preferably be summarized in a PDF (max. 10 MB) and contain the following information:

- artistic CV with exhibition activities, projects, references
- a short statement on your own work and a short letter of motivation for the membership application
- Proof of training / copy of artistic degree certificate
- Representative selection of works
- Information on digital presence (website, Instagram, etc.)

An admissions committee decides on admission. The applicant will then be informed of the decision; no reasons for admission/rejection will be given. (Applicants who do not have a university degree are requested to submit a representative selection of original works upon request).

After successful admission, a **one-off admission fee of € 25** is due. This fee and the **annual membership fee of € 120** are paid by direct debit. Membership supports the association in achieving the objectives set out in the articles of association.

Every member receives a membership card. This is updated annually at the office after receipt of the membership fee and allows, among other things, discounted admission to many public art collections and the discounted purchase of the International Society of Fine Arts (IGBK) membership card.

Membership of BBK Leipzig e.V. also automatically includes membership of the Bund der Selbstständigen / Deutscher Gewerbeverband Landesverband Sachsen e.V..
